PW: All right, I'm gonna turn it on, too, coach.

RJ: Okay. My name is Rich Johanningmeier. I'm an associate director of enforcement for the NCAA. The date is November 6, 2007. This is an interview with Lloyd Lake. The interview is being conducted in a conference room of the office of Mr. Lake's autoruey, Paul Wong. And the address of the lucation of Mr. Wong's office is 234 East Colorado Street, Pasadena, California. - RJ: Okay. And, uli, prior to turning on the recorder, you signed a, uli, statement of confidentiality with the NCAA and with that, uli, we will, the NCAA enforcement staff is going to provide you a recorded copy and a transcript of this interview and that information will be sent to Mr. Wong. Is that our understanding and agreement?
- LL: Yes,
- RJ: Okay, thank you. And we would ask you to, uh, please limit the discussion of this interview to the appropriate representatives of the NCAA and in, uh, due time, uh, hopefully the University of Southern California and the Pac-10. And prior to turning on the recorder, uh, the NCAA enforcement staff has agreed with uh, Mr. Lake's attorneys that, uh, the information that is, uh, recorded and provided to us today will not be turned over, uh, or access given to the University of Southern California or the Pac-10 until such time as Mr. Wong and Mr. Watkins advise us that it's okay to do so. Is that our understanding gentlemen?
- PW: That was perfect.
- RJ: Thank you.
- PW: That's correct.

- AC: And the NCAA, for the record does request as so on as possible to be able to share that information, to do so.
- PW: We understand that.
- RJ. Okay. Also, uh, Lloyd, prior to turning on the recorder, you provided for us this contact information. I wanna make sure that it is correct that you reside currently at 743 South 61st Street, San Diego, California. You use your cell telephone and that number is 619/534-3491. Is that all correct?
- LL: Yes, sir.
- RJ. You are currently working, uh, with your mother in real estate development, and your business telephone there is 619/262-0868.
- LL: Yes, sir.
- RJ: You have, uh, you have not attended or graduated from any NCAA member institution?

- RJ: Nor are you a donor or season ticket holder at any NCAA member institution?
- LL: No, sir.
- RJ: And the purpose of this interview, uh, Lloyd, is to determine if you have knowledge of or involvement in any possible NCAA violations of NCAA legislation that may have occurred in the University of Southern California's intercollegiate athletics program. So that's what we're here to visit with you today. As you aware of that?
- LL: Yes, sir.
- RI: Thank you. To start off with, tell us how you first met and developed a relationship with Reggie Bush? Take us from the very start because, uh, don't assume that we know anything from news accounts. Rather, we wanta learn from you exactly how this occurred.
- LL: Okay. My dad, uh, owned a product called Sport, uh, (unintelligible) Sports Balm, kind of like, uh, Ben Gay, pain relief. But, uh, Reggie used to wear it in high school; he used to use it for his aches and pains. So one day my d ad asked me to take it to Reggie for him and that's how! developed a relationship with him from there.
- RJ: What, what was, uh, what year was it when you first, uh, got to really knuw Reggie and Reggie knew you?
- LL: Uh, probably '01.
- RI: And he was still attending high school at the time?
- LL: Yes, sit.
- RJ: Okay.
- UL: He was either a junior or soph, a sophomore or a junior.
- RJ: Okay, and so, and, and how did that relationship develop from there?
- LL: Uh, he jost kept using the product and him and my dad stayed in touch and we would just, you know, always, he's all right, conversation. He might call me in there but it was never really, uh, like we were best friends or anything like that. It's just that we were all right.

- LL: No, no, no. I've, I've been out of high schoolsince '92.
- RJ: Okay, so you were, you were just working with your dad --
- LL: Yeah.
- RJ: -- and you got to known him through that relationship?
- LL: Yes.
- RJ: Okay. And then, and then, did that grow to knowing the family? The Bushes?
- LU: I didn't really know the family. I got in, in a little trouble and got indicted and when I came home that's when I really started helping my d ad out again, when I came home, with his product and that's how I got back in the hop with them kind of sort of.

- LL: Yeah.
- RJ: Or with Bush and the Griffins?
- LL: Yeah,
- RJ: Okay.
- AC: So you, sophomore or junior year of Reggie's high school you were helping your dad, met him and then you were indicted and went away and came back?

LL: He was a sophomore in college when I came back home.

AC: Okay, so he was already at USC once you came?

LL: Yeah.

AC: And so the time that you were gone, did you have any contact with him?

LL: No.

AC: Okay. Are you aware of whether your father was, or your mother had any contact with him while you were gone?

LL: My father was in contact with him on the sport sticks, on the cream --

AC: -- at USC providing the sports cream --

LL: Yes.

- RJ: And that dad for the record, his name?
- LL: Lamar Griffin
- RJ: That's his stepfather?
- LL: Yes.
- RJ: Is that correct? Okay. So you, you, you --
- LL: And Denise Griffin, went with his mom.
- RJ: Okay. So the two, the, the Griffins, uh, went as a couple with you to a San Diego Chargers' NFL football game?
- LL: Yes.
- RJ: Okay. And explain to us what happens there?
- AC: Do you know when that was? Was that, what year that was?
- LL: So you'll forgive because of all these --
- AC: Sure.
- LL: -- dates, it's been so long, 1 --
- AC: Well after you came back, you said you came back from being incarcerated during Reggic's sophomore year at USC?
- LL: He was starting his sophomure season.

- LL: -- when he had, like two weeks out from there, a week maybe, we were in communi, I went and took some cream to his dad and his dad talked to me ahout some business opportunities involved with a sports agency and --

- LL: I mean, it wasn't right out of the blue. It was conversation and he was like I was thinking about getting involved in a sports agency 'cause I think my son's gonna go to the NFL. So, uh, I said I know a couple people that I could talk to for him, and that's wheo I introduced him to Michael Michaels.
- RJ: And how did, how did you know Michael Michaels, uh, at this time? How did you and Michael Michaels or --
- LL: I'd been knowing Michael Michaels probably for about 10 years.
- RJ: So you were long time --

- LL: Yeah, Yes.
- RJ: And why would you, why were you gonna introduce him to Michaels?
- LL: Because I, uh, when he brought up the, when he brought up the idea about the sports agency and what to do, and I told Michael I knew him and he was like, well, I wanna meet him. So that was basically it. I guess he'd been watching and knew who Reggie Bush was and at the time maybe wanting just to meet his family.
- RJ: And that's why you invited them to attend a San Diego Chargers' game?
- LL, Yes.
- RJ: Okay. Let me make sure we're understanding you correctly. You meet, you meet Bush basically through your dad's business.
- LL: Yes.
- RJ: Okay, and, uh, the relationship grows kind of off and on. Uh, when he's a sophomore at USC, you begin to, you make contact with Lamar Griffin?
- LJ.: Yes.
- RJ: Lamar Griffin talks to you about the possibilities of starting a sports marketing agency.
- IL: It wasn't only that. It was different things but that, at the end, that was what seemed like, uh, the best maybe to, safe for him and that's what he ended up going with. He talked about maybe a McDonald's; he talked about other things but at the end that was probably what made the most sense.
- RJ: Okay
- PW: Might I suggest that you ask him specifically what other or maybe you should just tell 'em what other --
- RJ. Yeah, what other --
- AC: (Unintelligible).

RJ: -- what other business, what other businesses did he mention?

LL: They talked about real estate, uh, sports agency, music, different types of things that they wanted to get into.

AC: And, and when he was talking to --

I.L.: And he said --

AC: -- you about --

LL: -- it'd probably be better if he got the sports agency. I guess him and Reggie already talked about it to maybe save some of his money for his marketing and, and commissions for a agent, so.

AC: And when he's talking to you about this, is he talking about it in conversation that he's wanting to start this or is he talking to you about you actually being involved? 'Cause I'm trying to understand if you, you haven't been in contact for two years and you come out and one week or two weeks all of a sudden he's bringing business proposals to you.

LL: No, you gotta think when I went over there, the first time we started hanging out, talking it wasn't like, I just went over there one time from when I took the product. We started talking and conversating more and more, like every day we were talking so it wasn't just a onetime thing.

AC: Prior to you going away?

LL: No, no.

AC: After.

LL: When I came home.

AC: You started --

LL: After the first time --

AC: - delivering the ointment --

LL: - I was talking to him, yeah, I delivered the ointment. We had some good conversations, just talking and he's kind of like lonely, like call my phone and says hey swing by the bouse. I didn't have nothing to do so that was a way to keep me out of trouble so I'd swing by, watch TV with him, maybe a football game.

- AC: -- developed, like, not --
- LL: Yeah, it developed.

- AC: -- to get an understanding 'cause I wasn't tracking on why all of a sudden he would be proposing business ideas.
- LL: Oh, no. It wasn't right off the blue. There was talk about 'cause he, I guess watched what my dad was doing with his product and he wanted to get involved with some type of business and --
- AC: Okay.
- LE: —at the end, when he met with Michaels, I gue so when they got to talking the sports agency seemed like the thing to do 'cause Michaels affiliated with Sycuan and, you know, they had plenty of money if we were going do it. So I guess that's what they end up running with.
- RJ: How, how serious was the conversation at the Chargers' game about going into the sports marketing?
- LL: It wasn't too serious. It wasn't serious until Reggie actually came and talked with us.
- RJ; And when did that happen?
- LU: 'Cause you know Lamar, that's like Michael Jordan's mom or somebody talking. I mean, they can't really talk fur him to get you really enhused. Ub, Reggie came down probably three weeks after that and, ub --
- AC: Do you know who the Chargers were playing?

LL: I don't remember, it's been so long.

AC; Okay.

LL: I know we were in the Sycuan box though.

AC: Okay. So did you get the tickets from Michael Michaels?

LL: Yes.

AC: Okay. And so the game, it was Lamar, Denise, you --

LL: And Jovan.

AC: And Jovan?

LL: Yeah, that's his brother.

AC: Uh-bah.

LL: Ycab.

AC: And Michaels?

LL: Yes.

AC: Okay, so --

LL: And all Sycuan tribal members.

AC: Okay. And so then it was an informal discussion of the business deal?

LL: It wasn't too much --

AC: Or was it --

LL: - talk about business then. At the game --

AC: Okay.

LL: -- actual game. Michael gets, you know, I told him what they had proposed to me and I talked to Michael. He met 'em at the game and it wasn't too much talk at the game, just

And then Michael told me, like, you know, I'm not gonna do anything, no, unless I heard something from Reggie's mouth I'm not gonna move because they're saying they can do something. So Reggie came down a couple weeks later. After some conversation in between about doing it and Reggie came down and confirmed that he wanted to do it.

- RJ: When, when Reggie came down, where did that meeting take place?
- LL: Uh, Reggie came down it was at the house that they moved out of, in the parking let, in, in, uh, Spring Valley before they moved into the house that Michael Michaels purchased.
- RI: So they were living in Spring Valley --
- LL: They were living in a condo, too, in Spring Valley on Paradise Valley Road.
- AC: Uh-hah.
- RJ: And who was all there during that discussion?
- LL: It was me, Michael and chief, I mean, me, Michael and Reggie. Chief is Michael.
- AC: Okay.
- LL: That's what I call him.
- RJ: Did La, was Lamar taking, uh, did he --
- LL: No, he wasn't even out there when we were talking because we didn't wanna have him.
- RJ: To the best of, the, the, the best you can recall, tell us about that conversation that, that took place?
- LL: Well, I remember Mike asked him like, you know, basically tell him what his dad was talking about add, wh, he asked Reggie were you serious about it that you wanna go and get involved before he, you know, tried to make something happen. And Reggie said, yeah, and it just moved on from there. Reggie was like, yeah, I really wanna do this. I wanna be in the business and really entrepreneur-type stuff, so.
- AC: Who arranged for that meeting? For Reggie to come down?
- LL: His dad, uh, I think or he might've just been coming in town. I don't think it was like he came just to see us. But he's coming in town so you guys can come over here and sit and talk with him.

- LL; Yes.
- RJ: Okay.
- LL: Yeah, that, I'm, I might be kind of shaky on dates 'cause it's been so long.
- AC: And I just wanua, I just wanna understand all these relationships. Once you got out, I understand you built the relationship with Lamar. How often would you speak with Reggie once you came back during his sophomore season before that meeting occurred in the parking lot?
- LL: How often would I talk to Reggie?
- AC: Yeah.
- LL: Not too much, not too much 'cause --
- AC: Were you --
- LL: I knew he was busy.
- AC: -- and you would communicate with him?
- LL: Yes, yeah.
- AC: Okay, by cell phone?
- LL: Cell phone.
- AC: Okay.

LL: Yeah, you mean as far as club, go out and hang out?

PW: You also knew his cousin now, right?

LL: Bennett, Darryl?

PW: Yeah, a guy, isn't it --

LL: Yeah, he lives in San Diego and you know where, uh, like I said cousins or play cousins, I don't know but know but be's my friend, too. So, uh, that's another reason how the relationship. But, you know, we went out to a couple clubs. We went to Fasion Love, T-Mac, his runningback coach, uh, I don't even know the name of the dude.

RJ: Reg, Reggie's ruoningback coach?

LL: Yeah.

RI: Reggie?

AC: T-Mac?

LL: Yeah.

AC: Do you know his full name?

LL: Uh, McNair I think.

RJ: But did he call him T-Mac?

LL: Yeah.

RJ: And would Todd McNair make --

LL: Yeah, that's it, McNair. Yeah.

LL: With, with, uh, Reggie wasn': in it but T-Mac and Fasion was in it. Reggie had got in a argument with, some girls were arguing and he wasn't in the picture but.

RJ: When, when did this exactly occur? When you were socializing with Todd McNair and Reggie?

List. I mean it was two times. He came down for the Marshall Faulk party, too, and we got him that room, Reggie the room down there.

RJ: Okay.

LL: McNair was down there for that, too. But, this was right before the UCLA game.

AC: His sophomore season?

LL: Junior.

AC: Junior season?

LL: Yeah, I didn't go out any during his sophomore season with him.

RJ: And, and was this in Los Angeles or in --

LL: Los Angeles.

RJ: Do, do you remember what clubs you went to?

Idon't know the name of 'em but Larry Pearce vas, was with us, one of Reggie's friends, and, uh --

AC: Larry?

LL; Pearce.

AC: Pearce?

LL: Yeah.

AC: Did he play football at USC?

LL: He played with Reggie at Helix.

AC: At Helix, okay.

Ul.: Yeah.

AC: And did they, I mean, were they, you were communicating and he said hey, come on up or you were in the area and you rao into him or?

RJ: Yeah, help us understand whether this was just, uh, you bumped into each other -

I.L: No, this was after the game. We had went to the game.

AC: You went to a USC game?

LL: Yeah.

RJ: And it was a UCLA game?

LL: No, this was before that game. I don't know which game it was.

RJ: Okay.

AC: You were --

LL: I know they were playing U --

AC: - you went to a USC game?

LL: -- they were playing UCLA like the next game. They had like a two or three week break or something I remember.

AC: Okay.

AC: And so you had arranged to go out?

LL: Yeah, we went to the game, went in the locker room.

AC: And where, did you buy tickets for that game?

I.L: Name on a list. I forgot, what do you call it? Uh, like will call. Uh, will call, you know, when the player, like a recruit list.

AC: Comp list?

PW; Yeah, the comp list.

AC: The pass list.

RJ: Did, did you go under Lloyd Lake or?

LL: Yes.

RJ: There was, your, your name was on the pass list?

LL: Yes.

RJ: And who clsc was with you?

LL: Michael Michaels.

RJ: So you and Michael Michaels were on the pass list?

LL: Yes.

AC: Did you have to show ID?

LL: Yes.

AC: And did you have to sign anything --

- LL: Yes.
- AC: -- to get those tickets?
- LL: Yes.
- AC: And that was the game before the UCLA game?
- LL: I mean, I went to like two, two or three games like that where I had to sign.
- RJ: Okay, so you were, and this was all his junior year, not --
- LL: Yeah, all his junior year. I didn't go to any sophomore games.
- RJ: Okay. So you were at least three games during the junior --
- LL: Two or three,
- RJ: Two or three?
- LL: At least two of 'em though,
- RJ: And the one you're pretty certain of was the one that was, uh, uh, prior to, prior to UCLA?
- LL: Prior to the UCLA game. I think that that was their next game.
- RJ: When, when you, when you went into the stadium, where'd you sit?
- LL: Uh, one time we sat by Lamar and Denise 'cause we got their late so we didn't even go to our seats. Another time he had us way up and then, but he had us where we got in the locker toom after the game.
- RJ: How did you get in the locker room?
- LL: Reggie and his dad, I mean, you know.
- RJ: Did you have any kind of pass to get in there?
- LL: Yeah, I think I did. I've gotta look at the picture, I have a picture in the locker room.
- RJ: Who took the photograph of you?

- LL: Uh, I think Michaels did, Michaels took the picture.
- RI: And who's, who's involved in the photograph?
- LL: Well me, it's one with just me and you can see like some of the players in the background, and there's one where he took of Reggie and one of Matt Leinart in the locker room on a camera phone.
- RJ: Okay. Do you still have those photographs?
- LL: Yes
- RJ: Okay. We, hopefully you might be able to share a copy of those with us.
- LL: Okay, yeah.
- RJ: And then, so you were in the locker room, when you're in the locker room, did you did you meet any other players or coaches?
- LL: Nah, nah, I mean I met, I shook hands with 'em but, you know, like, uh, you know, Ken Norton, (unintelligible).
- RI: Who, who introduced you to Norton?
- LL: Michaels, Michaels knew him but my dad, I know his, my dad and Ken Norton, his dad are real good friends so I told him. He knew who I was and things from my dad.
- RJ: So your dad knew the Nortons?
- LL: Yeah, my dad used to do boxing promoting and bought the Ken Norton/Ali fight. He promoted that fight in San Diego.
- RJ: Okay
- LL: Yeah.
- RJ: And so your, uh --
- AC: Did Michaels know Norton as well?
- LL: Yeah, he knows Norton, too.
- AC: Okay.

- RJ: The prospects coming in?
- LL: Yeah, the prospects, those are the ticket we got.
- RJ: Okay.
- LL: On that second time,
- RJ: So you had pruspects' tickets?
- LL: Yeah.
- RJ: How, how, why do you remember that?
- EL: Because I remember, uh, I think somebody said you guys are kind of old to be, ahh, not to go to school or something. I don't remember. I don't, I just knew that they were for, uh, for, uh, recruit, you know.
- RJ: Okay.
- LL: Like, that they give to the players coming in.
- RJ: So after the game's complete, all right, the game's over, players are on the field and --
- LL: I go to Reggie's apartment, we meet there, we go to his apartment.
- RJ: -- but did you go into the locker room? That's my point.
- LL: Yeah, yeah.
- RJ: All right, so you come down out of the stands.
- LL: Go onto the field.

RJ: You're able to get on the, nobody stops you getting on the field?

LL: No.

RJ: Okay, so you walk on the field.

LL: Walk on the field, on the field, across the field to the locker room, inside the locker room.

LL: Yeah, he might've been a little ahead of, a little ahead of us, but --

AC: But he was waiting on the field for you guys to come down?

LL: Yeab, he's the one that got everyone on the field.

RJ: And then you guys walk into the locker room and no one at the locker room stops or asks you for any kind of identification?

LL: No.

RJ: And just go right in the locker morn?

LL: Yes.

RJ: Okay. Then what happens after you guys are done with the locker room? You mentioned you went to his apartment?

LL: Yeah, we went to his apartment and, uh, he took a shower and everything and, uh, we went and are at some Chinese, his favorite little Chinese restaurant.

RJ: Where was his apartment at that time located?

LL: Where was that apartment on Brian? On second or whatever it was,

PW: You've got to tell them.

LL: I know but I'm asking Brian.

BW: Uh, 310 Wilshire.

LL: Yeah, that's the one.

AC: From San Diego?

LL: Yes.

AC: Okay.

LL: And another one was Saro and, uh, that's it.

AC: Now is Sam a, a player, a USC football player?

LL: He used to play football with Reggie in high school.

AC: Okay.

RJ: Okay. So you're at the apartment then, then does the entire party go out to cat?

RJ: Okay. So you go to what, a Chinese restaurant and --

LL: Yeah.

RJ: Okay, and then from there what happens?

LL: From there we went to, uh, we went to the hot, got, go a hotel room to get dressed to go out to the club and then Michael and I end up getting one of, nh, Reggie's, Reggie asked me to get his friend a botel room and I got his friend one, too. Larry and Sam, then we went out to the club.

AC: And what hotel was that?

LL: The Marriott right across from his apartment.

AC: Okay.

RJ: The Downtown Marriott there in L.A.?

LL: That downtown there?

PW: I think Wilshire district, isn't it?

BW: Wilshire district, the (uniotelligible) district.

RJ: Okay.

I.L.: It was right across, his, his apartments or condos are right here and on the, across the light on the same side was the Marriott.

RJ: Okay.

LL: Right by there, across the street.

RJ: So you guys paid for his friend's room?

LL: Yes.

RJ: Okay, and then you guys basically got cleaned up --

LL: And went to the club.

- LL: I don't know the name of it.
- RJ: Where was it located?

- LL: Yes, I met him when he came down for the, uh, Faulk party. When we got the room for Reggie, he was in the room. He came through the room with Reggie.
- AC: So
- RJ: And we were probably gonna get onto that but why don't you explain that part to us, about how that all came about?
- Yell, Marshali Faulk was having a birthday part y and Reggie called me, uh, 'cause he needed a room. So, uh, Michael got him a suite down at the Hyatt, duwntown Sao Diego. So he got Reggie a room for the Marshall Faulk party.
- RJ: And then how does McNair connected with this?
- LL: McNair was down there, too, I guess for the party. So when I went to the room, McNair was in the room with Reggie.
- AC: And who else was there --
- LL: Just McNair --
- AC: -- in --

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

LL: -- with and Reggie.

AC: Just the three of you?

LL: Yes.

RJ: And that --

AC: And did you go to the party with them?

LL: Yeah, we went, well he rode in the lime with us to the Faulk party.

LL: No, it was Tony Qwinn's wife, uh, my sister, Michael, Reggie.

AC: And Todd McNair was part of that as well?

LL: No, he didn't ride with us.

AC: Was he aware that Reggie was riding in the limo --

LL: Yeah

AC: -- with you guys?

RJ: How, how do you know he was aware?

LL: Yeah, he was at the party.

RJ: McNair showed up at the party?

LL: Yeah, at the Faulk party, yeah.

AC: And Reg, who else was staying in that room?

LL. I don't know if McNair was staying in there with him or not.

AC: Did you stay in the room?

LL: No, no, no.

AC: Did Michaels stay in the room?

LL: No.

AC: And did anyone else from Reggie's friends up in L.A. or anybody else stay there that you

LL: I don't know.

AC: -- were aware?

LL: I don't know 'cause like I said, when I went inthere, I went and got the room for him, took him in the room, went somewhere else and I came back for a minute to talk to him, McNair was in the room with him, did a introduction. I left, I never knew who was in the room, I never went back to the room again, just to pick him up in the lime to go to the club but I didn't go in the room.

AC: You paid, you went and registered the room in your name at the Hyatt?

LL: It was in Mike's name but he left it where I could pick the keys up, too.

AC: Okay.

LL: So I can give Reggie the key.

AC: So Michaels arranged the room and paid for the room?

LL: Yes.

AC: And then left at the front desk that Lloyd Lake could come to pick up the key?

LL: Yes, or he either, or he either gave, or he either gave me a key.

AC: Okay.

LE: I'm not sure.

AC: Did Reggie drive --

LL: But I had the key.

AC: -- down from L.A.?

LL: Yes.

RJ: Okay. Uh, how long's the party last?

LL: To about 1:30, we got there about 11, 11:30.

RJ: Was McNair still there when you left or was, did --

LL: Yeah, he walked us to the limo --

RJ: When we were leaving?

LL' -- then we, yeah.

RJ: Well do you remember anything that he said ur anything?

LL: He just told Reggie to be careful, you know, be safe and stay out of trouble, and that was it.

RJ: And so you don't know if, if, uh, McNair went back to stay at that, uh, the Hyatt?

- LL: I don't know. I don't know.
- RJ: Did you go back to the Hyatt at all?
- LL: No.
- RJ: So you had not been back to that room?

- RJ: Okay.
- AC: Do you know who he was there with?
- LL: No.

- RJ: So out of that, if we're understanding you correctly Lloyd, McNair and Norton are the only two coaches at USC that you gays had ever met or knew of or knew each other?
- LL: Norton didn't know, even though I was there with Reggie. I'll be honest with you on that. You know, he never saw me with Reggie.
- RJ: Okay. But when you were in the locker room --
- LL: Yeah, but he never knew I was with Reggie.
- RJ: Okay. So he just saw you in the locker room?
- LL: Yeah.

- LL: No.

- RJ: Don't assume anything. Tell us about what --
- LL: Okay, well --
- RI: -- e-mails
- LL: —I get, I get some calls from Lamar and Reggie like back to back, panicking like, you know, chany God, if SC, if anybody calls, you know, just say this and, you know, for the house just go by my dad and talk to my dad. So when I go by and talk to Lamar, be calls Pete Carroll. I guess Pete Carroll didn't pick up so he called him. Pete Carroll called him back and Lamar put him on a speaker phone so I could hear him. They got a, uh, anonymous tip that a agent had bought a house that Reggie was staying in and a car. And went from that, they would like call him, like, Lamar would tell him what he needed to get together, get a lease together, I'm listening because I have to get everything together for him. And, uh, Reggie, you know, he called me like if they ask, you know, just say my dad bought this car for me. First he said, then, then he called me hack and said, no, just say my dad bought the car if they ask, you know, because they were put, I guess they got tipped by e-mails.
- AC: Uh-huh.
- LL: From a anonymous source that Reggie was staying with a agent, a house that a agent bought for his family. And of course, so Pete Carroll --
- AC: We might waim back all the way up to where the meeting in the parking lot so we can work our way up to all this because we kind of jumped to the party.
- LL: Yeah, we did.
- AC: So we, if that's, I, I was, so you, let's jumpback to the meeting in the parking lot.
- LL: Okay.
- AC: 'Cause this is where it all started in late October, late November of '04?

- LL: Ub-huh.
- AC: Reggie comes, you were already in discussions with Lamar and Michaels about a sports agency.
- L.L.: Yeali.
- AC: They wanna get Reggie's approval. Reggie --

- AC: -- get Reggie's approval?
- LL: Well, yeah before do.
- AC: Reggie comes down from L.A. to San Diego and meets you and Michaels in the parking lot of the condo that they used to live in?
- LL: Right.
- AC: Okay. In that meeting, Reggie indicates that he's on board with this?
- LL: Yeah, Michael said, you know, your dad's been telling me you wanna start a sports agency. You know, I'm not gonna do anything, uh, ite my time up on what they're saying. I wanna make sure that that's something you really wanna do. And Reggie was like, yeah, you know, I wanna do it, a sports agency and that's what got Michael involved.
- AC: Okay. And how long --
- LL: He didn't wanna get involved just --
- AC: was that conversation?
- LL: -- probably about 15 minutes, 10 minutes.
- AC: Okay. And so you get, Reggie says he interested in this?
- LL: He says let's do it and he tells Michaels this what I wanna do. Let's do it.

RJ: So your understanding at that time and Reggie's understanding was you guys were gonus put together and develop a, a complete --

I.L.: Yeab, his family, his family, he like, I can't be on it but my family gets half my percentage when we can do it right, the percentage to his family. You're always covering it up.

AC: You wanna break, you're eyeing it? Uh, so he, he goes along with this and says his family's gonna be involved and, and because I wanna ask this question, was that the first time he had met Michaels?

LL: Yes.

AC: Reggie?

LL: Yes.

AC: That was the first time?

LL: First time.

AC: Did he ask any questions about who he was, what --

LL: No, because I already --

Was that ever discussed, was it ever brought op?

LL: What do you mean? As far as my background?

AC: Yes.

LL: No.

AC: Okay. So they never --

LL: They knew about it though.

AC: -- they knew about your previous --

LL: It's on the tape that he knew about it and he says and, you know.

AC: Well, I, again, we don't know anything --

- LL; How old is he? About 35.
- RJ: He's in your age bracket?
- LL: Age bracket, yeah.
- RJ: What's he do for a living?
- Uh, he's gots a co, a shirt company, a clothing company. Reggie as a matter of fact was doing it with him at first but I don't know what happened.
- AC: Okay.
- RJ: Okay.
- AC: So you have this meeting and Reggie says okay, we're on board. What were the next steps? What were the next steps once Michaels was comfortable?
- LL: Well first it was never any discussions about money. It was just get it started. And then once Reggie gave that approval, they all started asking for shit, once they said, nh, excuse my language. It was already, okay, we're gonna do this. Now can we get this? Now can we that? We'll make it back and you know.
- RJ: Okay, belp us from this.
- LL: First thing Michaels did was give the parents \$28,000 dollars.

RI: Okay, but you make the agreement in the, in that parking lot basically.

LL: Right.

AC: Prior to that had you ever, had either Denise, Lamar, Joyan or Reggie ever asked you for

LL; No.

RJ; Okay.

AC: So prior to that had you ever provided them anything?

LL: No.

AC: Free ointment?

RJ: How about Michael Michaels?

LL: Yeah, he gets the ointment.

AC: Okay.

LL: Yeah, that was the marketing I said, but as far as like anything outside of that, no.

AC: So any money, gifts, anything like that --

LL: No, just those --

AC: -- prior to that --

LL: -- tickets to the game that we went to.

AC: Okay. So the tickets, they did not pay for?

LL: No.

AC: Okay. So prior to that agreement, nothing was ever provided to the Griffins other than the tickets and the ointment?

LL: Yes.

RJ: To your, to your knowledge did Michael Michaels provide 'em anything up until that point?

LL: No.

RJ: Okay.

AC: So the agreement, let's move forward, Reggie gives his okay, what's the next -

RJ: What's the very next thing --

AC: -- or how, what's the next thing --

RJ: -- that happens?

AC: -- step in where?

I.I.: The very first, the very very next step is, okay, since we're partners now, this is Lamar, since we're partners now, we, we fell behind on some bills, credit card debt, you know, we're behind in our bills, we need a loan.

AC: Was that the same day? How far after when --

LL: That was like two days later.

AC: Two days after you met --

LL; Yeah.

AC: -- with Reggie, Lamar comes to you and has, says he's got financial problems.

LL: Yeah.

AC: Comes to you or comes to Michaels or how did --

LL: Comes to me.

AC: Okay.

LL: And I said I don't have that money right now but, uh, I can ask --

AC: Where was that conversation occur? Do you remember?

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

LL: At, at his house. I always went there --

AC: At his house?

LL: - like every day like I told you.

AC: Okay.

LL: I can't really just, you know, break down the exact times and dates 'cause it's been so long. I never thought I would ever have to, so I'm not thinking, remembering.

RI: Was there anyone else there when he asked you for the, the assistance?

LL: Denise credit cards, whatever, they both all together said they needed \$28,000.

AC: They came with that direct number?

AC: Okay. And what did, and so they make their request?

LL: So I, I, all I could do is run it by to Michael. Michael was like okay, sure, no problem.
He gave me the money and I went and took it to 'em.

- AC: Give you \$28,000 dollars in cash?

- AC: You talked to Michaels --
- LL: In person.
- AC: in person?

- RJ: What kind of bills?
- LL: Big bills, all hundreds, I think it was all hundreds.
- RI: Did it, was it in an euvelope, suitcase, how did you carry that?
- LL: Nah, it wasn't a suitcase, it's \$28,000, (unintelligible), you know, a hundreds is not that much if it's all hundreds. It was an envelope I had it in.
- RJ: Okay. What kind of an envelope?
- LE: Sheesh, I think it was just a envelope, a white envelope if I recall.
- RJ: Okay.
- AC: And so be handed you \$28,000 dollars in cash, you take that to Lamar and Denise.

- LL: To Lamar and Denise.
- AC: And where did you, at their house?
- LL: At their house,
- RJ: And --
- AC. And --
- RI: -- go ahcad.

- LL: And Denise was right there, too, though.
- AC: Okay. Was anyone else there?
- LL: No, just those two.

- J.L. Yeah, I told him before, you know, that, you know, your family was in debt on that one. And he, like, uh, wait, wait, wait. I don't know. I, uo, I don't, I don't know if he knew about that.
- RJ: The first \$28,000?
- LL: No, I don't think he knew. I mean, he had to know though. When your family doesn't have any money and all of a sudden now he's buying a car and doing this? I mean, he knew where it was coming from, had to have known.
- RI: But you never had any specific conversations with him that hey look, uh, Michael Michaels has put up this, these foods for your family?
- LL: Yeah, I, I had a couple but we never was no amounts, we never talked about amounts.

- LL: I know Lamar bought a green Cadillac, that Cadillac that he has. Uh, they said they had credit card debt for like \$15,000
- AC: How far after that you gave them \$28,000 dollars that the green Cadillac was bought?
- LL: The next day.
- AC: The next day?
- LL: The next day and I --
- AC: Were you aware that he was using that money to buy --
- LL: No.
- AC: -- a car prior?
- I.L.: No, 'cause I asked him, I said, I thought it was a debt. He said, yeah, yeah, but I needed a new car.
- AC: Was it a brand new, no.
- LL: It wasn't brand new, it was about --
- AC: What kind of car did he have prior to that, do you know?
- LL: Uh, yeah, it was a, a Mercury I wanna say.
- AC: Lamar had a Mercury?
- LL: Yeah.
- AC: Okay.

RJ: Uh, give us a timeframe. You said that it was sometime in October when you met with Reggie in the parking lot. So are we still in Octo ber when you, when, uh, Lamar tells you?

RJ: - talking, and this is his ju, junior year?

AC: Sophomore.

LL: Sophomore year.

RJ: Okay. It's his sophomore year.

RJ: All right, so we're talking, uh, end of, somewhere close to end of October is when you had the initial meeting with Reggie and Michaels, and knew that you guys were gonna become partners in this --

LL: Sports agency,

RJ: - sports agency business?

LL: Right.

Right after that, that's when Lamar says hey look, we've got these needs, it's gonna cost us this amount of money.

LL: Right.

RJ: Okay. And that's when you deliver?

LL: Yes.

RJ. Okay. So be purchased that car sometime in November?

LL: Right.

LL: No, no, uh, Lamar did.

RJ: Right.

AC: I mean, what --

LL: -- it was dealing the business was going on, what we needed to get done.

AC: So every day once the approval from Reggie came, you guys were starting to work on this business?

LL: Business, too, yeah.

AC: And was that prignarily you and Lamar? Who was involved in those conversations?

LL: All of us.

AC: Okay.

LL: Michaels.

AC: Did you meet or would you talk by phone or --

LL: We had a lot of meetings, a whole bunch of meetings. Well some --

AC: Did Lamar work?

LL: Yeah, as a security guard, yeah, at the high school.

- AC: During the day or during the night?
- LL: During the day,
- AC: During the day?
- LL: Yeah,
- AC: So would you ever, when you said you'd go over there every day, was that after he would work?

- LL: No, they didn't, they occurred at my house, some at Michaels, you know, some at their, most of, a lot of 'ero at, uh, Sycuan's resort. They've got a casino and golf, I mean a golf course, a lot of meetings down there.
- RJ: Now how structured were those, uh, Lloyd? Did, did you actually say guys were goung get together on Wednesday?
- LL: Well, yeah, they were structured, a lot of 'em were structured.
- RJ: So this wasn't just sitting around shooting thebull?
- LL: No, no, no. Attorneys a couple of 'em, corporate attorneys.
- AC: From the tribe were there?
- I.L.: No, I mean, nh, from when we went in to a, see, I, keep having to jump when we do that.

So I gave him and his dad the money, really to his dad and he took him up there and called me from the lot and Reggie put the 13 down on the car, then he, right after that he's like I need to get some rims. So I gave him like six, five or six more thousand for the rims and the alarm and the music.

- AC: But elaborate on, on the --
- III. Imean, they, you know, we were aware that what we were doing wasn't, I guess, you know, couldn't give him money, he didn't wanna drawany, ub, he didn't wanna draw any

- AC: -- using cash and not putting his name on anything?

- J.L: And, uh, I know, I gotta get the receipts, I know we bought the tickets for that sophomore year Rose Bowl, the travel agency right now, travel agent right now went out of business but says she still has her files where my brother-in-law bought the tickets, but their names are on the tickets for the sophomore season.

- LL: To go to Miami.
- AC: -- to Miami?
- LL: Rose Bowl game.
- AC: And who?

- LL: I'm pretty sure if you go back, I don't know how far you guys can go back but it was so many cameramen out there, I guarantee somebody picked me up out there. That's how many people, media was out there. It was the beginning of the season, too, one of em, I don't know.
- RJ: Did, uh, did, uh, did you talk --
- LL The junior season.
- RJ: -- did you talk to any coaches or any coaches come up to you when you --
- LL: I talked to a few players I remember, but nobody really asked too many questions.
- RJ: How many occasions were you over on the, at the practice?
- LL: At least two, three.
- RJ: This would ve been his junior year?
- LL; Yes, his junior year for practice.
- AC: Anybody clse go with you?
- LL: No.

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

AC: Just you?

LL: Yeah,

AC: Were there other spectators or general public in there?

LL: No, it was closed to everybody else.

AC: Okay.

RJ: But, but normally the gate's closed, correct?

LL: Yeah, they opened it.

RJ: And who was at the gate, do you remember?

LL: I don't, I can't recall. I can't recall.

RJ: But you, but you had to, did you have to tell somebody your name or just tell 'em, how, tell, tell us how, you know, as best you can recall?

LL: I don't think I had to tell acybody. I, I just think I said I was here for Reggie. I think Reggie might've just told the person at the gate if I recall because they never asked for my name.

RJ: What, what'd you do on those occasions after practice? Did you go out with him or what happened?

LL: Give him money, that's what I was up there for.

AC: Okay.

RJ: But one other while we're on this --

AC: Uh-huh.

RJ; -- ever attend any other contests or games with any other USC intercollegiate sports --

LL: No.

RJ: -- and that? So the football and the practice was the only time on campus?

LL: Yeah.

RJ: Okay.

AC: And, uh, just so 'cause I keep going back to this husiness, who, when did the name, when did you come up with the first name? Who came up with that?

LL: Michael came up with that name.

LL: He got approval from everyone, Denise, Lamar, me and then when we got, you know, they start complaining that Lem didn't have enough, well, we knew that from the beginning and we told 'em we was gonna out and subcontract another big agent to work on the deal with them, so they knew everything --

LL: -- from the beginning, Lemuel Campbell, my sis --

AC: Okay.

LL: -- okay, and then that's when they said, no, you've gotta go get another agent with more experience.

AC: Who said that?

LL: De, Denise and Lamar.

AC: So, that you need to get a bigger --

LL: That when they got --

AC: -- agent?

LL: -- Dave Cervantes and had to pay him and they were --

AC: Okay. How did that, how did, how did David Cervantes get involved in this? Who reached out to him? Who knew him?

RJ: You knew Cer --

LL: I didn't know Dave.

AC: You didn't know Dave?

LL: No.

AC: How did you?

LL: His name just popped up as a good agent that --

I mean if you want somebody as an agent to represent you, I mean, you don't get too much bigger then Brett Farve and, uh, Randy Moss, so they have a expertise if that's the reason.
- AC: Uh-huh.
- LL: So we figured we were covered. That's why we took Dave.
- AC: Okay. So Lamar --
- LL: Randy used to work with the agent that Reggie signed with. They used to be partners.
- AC: Joe Siegel?
- LL: Joe Siegel and Dave used to be partners.
- RJ: So, so the understanding of this whole scheme, if we're understanding you correctly, was to get a organization or a business that represented for contract negotiations --
- LL: And --

RJ: - with the NFL, to do all the marketing --

LL: Marketing.

RJ: -- promotions.

LL: Everything.

AC: Okay. So you bring Dave in, everybody likes him and you start --

I didn't even bring that up even to you guys ever. But because there's no proof of it but that's what happened and that's why Mike bought 'em the house.

AC: And what do you mean you did the loan?

LL: I was loan officer on the house.

AC: Okay.

LL: I got them the loan from Mike.

AC: Okay.

LL: Yeah, for that house?

RJ: Who actually owned the house?

LL: It was brand new, no one ever lived in it.

RJ: Was it a builder or who did you purchase --

But when they did all these upgrades, he had to come out of his pocket. It was like 18, 20 grand, I can't remember the exact number.

- LL: And I remember he had got mad. It was like Lamar just, you know, excuse my language but he was like this greedy mother fucker just taking advantage of the situation.
- AC: And so were there discussions about, when the discussions we're trying to buy a house, about rent, whether they were gonna pay rent, they were gonna pay anything to live there?
- LL: They were supposed to just pay, uh, they were supposed to pay the rent and give it all back at the end. I think that's how they worked it out because I was paying half, I've got check stubs to show I was giving Mike half the rent. But Reggie was supposed to reimburse that at the end. They were supposed to originally put 1,400 with it, what they were paying.
- AC: They were going to pay \$1,400 dollars?
- LL: They were supposed to but they never paid a penny.

U. Soon as he got that he tried to say, well, it's summertime and I don't have. Soon as the house got done he called, you know, when it was time for rent we were like, uh, Mike was like call and get the money right from that time. Uh, uh, you know, it was summertime and it's about to be summer and, uh, my pay is cut because I'm not working fulltime, I don't have it.

AC: Who was gonna pay the bills for that house?

LL: They were supposed to pay, they paid the bills I think.

AC: Okay. So they were, when this whole agreement it was gonna be they paid \$1,400 dollars in rent and they paid the bills?

LL: Yeah.

LL: Well at the end I ended up, well, putting out, where the checks, half of what Mike was paying.

RJ: Which was what all together?

LL: It was 4,200 so 2,100.

LL: I don't know. It was only about three or four 'cause we were like they not sticking to their agreement. I got the checks stubs that you can see that my more was giving to Michael for the house.

LL: Nine months or --

PW: I served the eviction notice in February.

RJ: February of 2006?

PW: Yeah.

LL: 11 mombs.

- RJ: Okay. And during that time how many, uh, they never paid any of the --
- LL: They never paid a dime. Can I take this call real quick?
- RJ. Okay. We'll go off record then for a second.
- PW: Now there's some really crazy people out there.
- RI: We went off record at approximately --
- AC: Lagree.
- RJ: -- 5:15 It's now about 5:17 for, uh, Mr. Lake to, uh, answer a, a phone call. All right. When we finished we were talking about, uh, the, uh, home on Spring Valley that, uh, that actually, the actual purchaser was Michael Michaels, correct?
- LL: Yes.
- RJ: And you were, you said you were the loan officer?
- LL: Yeah, I did the loan.
- RE And, uh, it was 100 percent financed except for the upgrades?
- £L: Yes.
- R.): And that, uh, they, that the Griffins resided in that property from approximately March 2005 to February 2006?
- LL: Yes.
- RJ: Earlier when you, we were talking, you mentioned that something happened regarding an e-mail, a phone call. Can you go into detail and explain to us exactly what happened?
- LL: Well I get a call like back to back from, Reggie I think called me first and then Lamar. He was like, uh, they pulled Reggie into the office and they asked him about the car and the house. So he basically told --
- AC: When you say who, who pulled --
- LL: Pete Carroll and all the coach, uh. Pete Carroll, the athletic director, they pulled him into the office.

- AC: And who told you that?
- LL: Reggie did.
- AC: Okay.
- I.L.: And I heard Pete Carroll talking with Lamar. He didn't know I was there but Lamar was fetting me hear everything I needed to get just in case somebody came and asked about the situation.
- AC: So you heard Pete Carroll on the phone talking --
- U.: Yeah, telting Lamar --
- AC: -- to --
- LL: what he needed.
- AC: Was that on speakerphone?
- LL: And on the speaker on his, on his trio phone.
- RJ: Go, go back through it as, as, as best you can recall exactly what was said?
- LL: Hey, man, man. They called me into the office, you know, he called panicking like.
- AC: Reggie called?
- LL: Reggie did. And, uh, basically told me, uh, you know, first he said say Bandit, if they ask about the car anyway, just say Bandit bought it. Then he --
- AC: Bandit?
- LL: That's Darryl, who I was telling you about 'flat's his --
- AC: Okay.
- LL: -- nickname, Bandit.
- AC: His cousin?
- LL: His cousin.

- LL: Called me back later, like 10 minutes later and he say, no, no, my dad bought it, my dad bought it cause he just got a, a workman's cump sedement for like 26 grand.

- AC: Okay.
- LL: So he was like just say my dad bought the car and gave me the money if they ask you. And, uh, call my dad, my dad right now and let him know exactly what you need for the house. So I called his dad. He told me to come over.
- AC: You called --
- LL: Lamar.
- AC: Okay.
- LL: Called him back or whatever and then he told me to come over there. And he tried to call Pete Carroll, he didn't pick up. I'm still at the house, Pete Carroll called him back. He put him on the speaker and Lamar was basically asking what he needed just in case someone came and asked him what was going on.
- AC. Okay. When that call, Pete Carroll called back, was Pete Carroll aware that you were in the room?
- LL: No.
- AC: So Pete Carroll didn't know that anyone else was --
- LL: No.
- AC: -- there? When the phone and he puts him on sp eaker, what exactly, do you remember what exactly, how did, was be aware of the house at the time, did he --
- LL: Yeah, the e-mail, that's why he was telling Lamar what be needed.
- AC: And what exactly did he say he needed?

- LL: Uh, told him, that's when we get the leases together, get a lease and show that you have a lease and, and, uh, make sure that you guys been paying all the rent, nobody's been helping you, appear on the lease that way. And --

- LL: No, I don't. I could check my phone records probably. It was in, I don't know if I looked, though I could tell because --
- RJ: What, what month would, would it have been?
- LL: It had to be, let's see March they bought the house, right? It had to be either April or May.
- PW: Yes, don't talk so loud.
- I.L.: I'm trying to think. It would have to be, 'cause I think it was right when the season was starting' 05.
- BW: (Unintelligible).
- LL: I'm speculating 'cause I'm not sure so don't, think it might've been like --
- PW: Do you want me to grab the lease?
- AC: The lease was dated --
- RJ: In May.
- AC: -- Memorial Day, correct?
- RJ: Memorial Day.
- LL: May of what?
- BW: '05.
- RJ: I think that's correct, '05.
- I.L.: Then that's probably when it happened 'cause wedidn't have a lease april that phone call. There was pover a lease.
- AC: So there was no lease when the house was bought?

- LL: No, no.
- AC: There was no --
- LL: We didn't get a lease until that day,
- AC: -- or rent agreement or anything like that?
- LL: No, we didn't get a --
- RJ: What was your understanding of what Pete Carroll knew about the arrangements on the house?
- LL: They said it was an auonymous tip that he was fiving in a house bought by agents.
- AC: Did he ask whether or not, I mean, did Lamar confirm that or was it ever discussed?
- LL: That's what Lamar told me, and Reggie told me about the e-mail. The e-mail is an anonymous tip that they're living in a house bought by agents and Reggie's driving a car bought by agents.
- RJ: Okay. So then when Pete Carroll calls, from that conversation does Pete Carroll say anything that would lead one to believe that he kne with they were living in that house with other people paying for it?
- LL: Yeah, 'cause he told him to get the lease together. I mean, basically he gotta know if someone's paying \$1,400 dollars a month and barely getting by making that rent, they can't possibly pay a \$4,200 dollar a month mortgage. It's impossible. You can't even make \$1,400 dollars you fall behind.
- RJ: And when he suggests that they get a lease, exactly, did he --
- LL: He would, no, he said what do I need for the N-C-double-A if they come? I remember the language 'cause Lamar was asking him.
- AC: Lamar --
- LI.: Because they thought that the Pac-10 or somebod y else was gonna find out and that was the purpose of getting a lease.
- AC: So on that call specifically, Launar asked, what do I need for the NCAA?

- LL: Yes.
- RJ: Okay.
- AC: Was there anyone else in the room with Pete Carroll that you were aware of?
- LL: No, no, no. I didn't, I don't think so.
- RJ: What, what was your understanding from where was Pete Carroll calling?
- LL: I was figuring from the school because I thought Lamar called him at the office. I'm not sure though, all speculation.
- RJ: So, so if the lease was done in May and again, we're just trying to, would that call have been done in May?
- LL: That's what I'm figuriog, yeah.
- AC: How quickly after --
- LL: 'Cause we didn't have a lease --
- AC: -- that call did the lease get drawn up?
- LL: The next, uh, day or two.
- AC: So after the call, the next day or two the lease was drawn up?
- LL: Yeah, we didn't have a lease before that.
- AC: Who was involved in drawing up the lease?
- LL: I think my brother-in-law got it done if I recall, Lem.
- AC: Okay.
- LL: So.

- I.I.: Yeah.

AC: Did he --

LL: So be --

AC: -- have to sign that lease?

LL: Did he sign that B7 Like I said, I let my brother-in-law handle it.

AC: Okay. So your brother-in --

LL: I dou't remember exactly --

AC: --law would be the one, he is the one that had everyone sign the proper signatures signed on that?

LL: If I recall.

- PW: I do but not here right now.
- RJ: Okay. But you would have that number?
- I.L.: I, yeah, I have it somewhere, on phone bills.
- RI: Okay. What, do you, do you re, do you recall if, uh, do you recall if, uh, coach Carroll was down in the San Diego area, did you at any time during the time that lease was being done?
- LL: I don't think so. I'm not sure.
- RJ: You never had any reason to see him or --
- LL: No.
- RJ: talk to him in person?
- LL: No, no.
- RJ: Okay. Do you have any reason that he would ve been there and had any kind of personal contact with Lamar? Did Lamar ever mention anything to you?
- LL: No, he didn't mention anything.
- R.I: Okay.
- AC: Was there any, uh, was it necessary to confirm with Pete or with anyone at USC that the lease had been drawn up and signed per that call?

- LH.: I'm pretty sure that they wanted to see it. I think they wanted a copy or at least see there was a lease.
- AC: So, do you ever --
- LL: I'm not --
- AC: -- are you aware whether that ever got forwarded to anyone at USC?

- AC: Okay.
- LL: Because I think they were, I'm not sure. I, Idon't know.
- AC: Once they were not paying rent, were there any discussions with them about, I mean the, the first couple of months that they're not paying, I mean, it sounds like --
- LL: It was like the way where, where you're already in, where you gotta keep going down, what can you say? You know, they didn't pay 1,400 but you gave Lamar this money already. So it was not too much you can do.
- AC: So you just can --
- LL: Kept going, you know.
- AC: Okay.
- LL: All you can do.
- AC: Where were you in the process of the company at this point?
- LL: We were just waiting on Reggie. I mean, we weren't even, like, when we first started we weren't doing any recruiting or anything till Reggie was eligible. That's when we started.
- AC: Now, did you guys have a, a building or an office or anything like that?
- LL: We were, we were in the process of leasing some, a space out from another guy named Dave in La Jolia.
- AC: Okay.

AC: Lamar did?

He was just trying to get money. I think he never really planned on going. He was just trying to get money and use that situation to get money.

RJ: Was, was it, was it understood or was it ever said that Reggie was gonna come out after his junior year?

LL: Yeah, he told me he was coming out after his junior year.

RJ. When did he tell you that?

LL: His sophomore year. He couldn't wait to get his Ferrari and, you know, just talking about the stuff that he wants.

PW: Tell 'em about the Ferrari. Tell 'em.

LL: Oh, when we were supposed to go to the Ferrari? That's when Mike Ornstein called him though. I knew he was getting money from Ornstein, too, the whole time 'cause he told me.

AC: Okay. When was, when did he tell you he was getting money from Mike Ornstein?

LL: Oh, he told me he worked for him and the dude looks out for him.

AC: Okay.

LL: 'Cause I, and I, at Adidas or Nike, wherever he worked with him.

AC: When did Reggie tell you that he --

LL: 'Cause --

AC: -- when did he tell you that?

- LL: -- 'cause he had brought up the guy, you know, was trying to get him a deal with Adidas already.

- RJ: You mean by tickets --
- LL: Travel tickets, like airline, airline tickets and hotel and pay for the hotel. This was at the end 'cause it was funny to me. The whole year we've been giving him all the money for all their away games, buying the tickets and then like towards the end of the season, they stopped asking for money and tickets so I knew somebody was giving 'em the money and the tickets.
- AC: So you gave them money to attend all the away games?

RJ: Okay. So when you, when you mentioned, uh, the Griffins, besides the paying the rent and the 28,000 and all that, were they on any kind of monthly allowance with you?

- RJ: Okay. And so --
- LL: If I remember I'll let you know.
- RJ: -- but Reggie never mentioned to you how he got that job? That's just what you heard?
- LL: Yeah, Reggie never mentioned it.
- RJ: When did Reggie tell you that he was getting money from Ornstein?

AC: Weil --

PW: This is really, just keep, answer your question.

RJ: Go ahead, tell us about the Ferrari.

LL: Uh, that, that, what, that he, with Mike, when we were supposed to go to the dealership.

AC: When you're saying Mike, are you saying Michaels?

LL: Michael Michaels.

AC: Uh-huh.

LL: I'll just say Chief so, you know, I'll just usethe name Chief, so. Well, uh, that night we were going to the club, that's when I really knew something was fishy 'cause I asked Reggie, who were you talking to 'cause I could hear--

LL: They called me?

RJ: There was calls, uh, that call was made to your telephone number, correct.

LL: Yes.

RJ: From Todd McNair.

LL: Ycs.

RJ: Can you tell us what those calls were about?

LL: Shh, I don't even recall. Uh, let me see. What was the dates on it?

RJ. October 29th.

PW: Is that the night of, of, uh --

LL: That's the night of that party I think.

- LL: Todd, T-Mac, you know, that's how they do. Like, I, I heard a rumor that he got 50,000 when Reggie signed, McNair. I --
- AC. From who?
- LL: From Ornstein.
- AC: Who did you hear that from?
- LL: I don't, I don't know if it was Charles or, I don't know why (unintelligible), I talked to so many different people about it.
- RJ: Why would be get money from Ornstein?
- J.L.: I heard he was like part, helping Reggie to sway him Ornstein's way.
- RJ: Okay.
- AC: But at the --

AC: -- Marshall Faulk party, you indicated to Todd McNair that you were serving as sports agent to --

AC: And do you know when that, around what time that started happening?

LL: Probably some, uh, November.

AC: Okay.

LL: Because, uh --

AC: What did Michaels, I mean --

LL: Michael didn't catch on until at the end. He was way too slow.

AC: And so --

PW: What about catching Lamar in lies, little lies and talking to other people and lying to everybody.

LL: Oh, yeah, that, that was what really kicked it off, that's what I was gome get to it, when they got to recruiting phase and they was in the paper --

AC: When they got to what?

LL: -- the recruit, I mean, uh, uh, the recruiting agency thing and they had promised, we were gonna be in there. They, just the whole time we're saying like we've gotta play it off during these meetings to make sure that it looks like you guys were in the competition. We just chose you. That was at the beginning. But then they said in the paper that they

had a meeting with seven agents and we weren't one of em, they didn't even tell us about it.

AC: Who had a meeting with the agents?

LL: Reggie did.

AC: Reggie and --

LL: And Ornstein, and they put in the paper who all were at these meetings.

AC: Uh-huh.

LL: And that's when I knew for sure --

AC: Did you ask anybody about that?

LL: Yeah. Uh, that was, uh, Reggie said on, uh, that was just, that wasn't official. That was just put together. I shouldn't never done it. And then, you know, he, Lamar tried to lie and say it didn't happen. He was never there. And then the paper said Lamar was there. That's when I started taping. When that lie about that, I was like, okay, these people --

AC: Did you talk to anybody about taping?

LL: Just my mom.

AC: That you were --

LL: And Meisha.

AC: -- that you were worried?

LL: Yeah.

AC: And who else did you say?

LL: My ex-girlfriend.

AC: Oh, okay.

LL: At the time.

AC: And, and so how many conversations did you tape?

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

LL: Uh, four of 'cm.

AC: With?

LL; Lamar and Reggie.

RJ: Four total or four each?

LL: Four total, two apiece,

RJ: Okay.

AC: And, uh, with the, the conversations with Reggie, was Lamar part of those conversations?

LL: No, they were both separate.

AC: Okay. And they did not know that they were being recorded?

LJ\_: No.

AC: And so did you, was there ever a confrontation with either Lamar or Reggie indicating hey, are you paying me this money back? What's going on?

LL: Well, Reggie, see this is what happened. At the end, you know, he was like, I'm not coming.

AC: He told you he was not --

LL: He was like --

AC: -- coming?

LL: -- yeah, yeah, I'm gonna give your money back but then he would try to give me back like 40, 50 grand less than I gave him.

AC: Okay. Let's, he tells you --

LL: It's just --

AC: -- he's not going with you. When was that?

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

- LL: That was in like January, right after he signed or right before he signed with Siegel and he was like I'm gonna make sure you get your money back though.
- AC: He told you that verhally?
- LL: Yeah, and I was like, and I told him, no you go tta do more than that. We've gotta sit down and talk and figure out because it was money that he made me get, I wouldn't have never been in this if it wasn't for him. So I was like you're gonna have to help me with the money I've been giving Dave Cervantes, all of the, you know what I mean, the time I wasted in this because before I eveo did this, I took Reggie up to a piece of property, me and my morn, that my morn owns and I showed him the contracts just like we're here right now. I said, look, Reggie. Before we go ahe ad and do this, I got a contract right here and it was from Olsen Construction and it was \$3 million dollars with contingencies up to eight. I said, look, I can do this right now and I can get a preferred lender's spot and make me another million dollars for my pocket. I don't need to do this with you. Oh, no, let's do it, I'm telling you I wannado it.
- AC: All right. I know you're prob --
- LL: Yeah, you know, I mean --
- AC: -- do you know when the date of that was?
- LL: When I took him up to the house?
- AC: Yes.
- LL: That was at the beginning before we ever gave any money or might've -
- AC: So that was before the 28,000 that you gave to the parents?
- LL: Yeah, I just wanted to make sure before --
- AC: And who was present at that meeting?
- LL: Just me and Reggie,
- AC: Was your mom there?
- LI.: No, it was just me and Reggie.
- AC: Okay. And there was a contract from Olsen --

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

- LL: Olsen Construction.
- AC: Okay.
- LL: Yeah, with a \$3 million dollar deal and conting encies if some zoning can get changed where they were gonna give us \$8 million dollars.
- AC: Okay. And so just so my timeframe 'cause I know we're bad on dates, this is after you got out of jail?
- LL: Yeah, this is after I got out from two years.
- AC: His sophomore year?
- LL: Yes, his sophomore year.
- AC: Before you made the payment --
- LL: See what it is, this is before he blew up and I put it all together, before he, was bigger than life in his mind so.
- AC: Okay.
- LL: then he go too big.
- AC: So I just wanna try and crunch the timeframe as closely as I can.
- LE: 1 --
- AC: This is, you get out September, is that what we said?
- LL: I got out in October.
- AC: You got out in October?
- LL: Yeah,
- AC. And this is before you paid, uh, paid the 28,000. This is --
- Yeah, so it's somewhere in the October/November, it might be all at the same time when he gave the okay that he wanted to do it. That's when it was. When Mike, when he was out here and told Mike let's do it. And I took him up there and asked him, one and him,

like some reassurance before you get me tied up, I'm gonna leave this deal alone because I can't do 'em both. That's why I was showing himbat.

- AC: Was that the same day?
- LL: Yeah, it had to be the same weekend if not, but it was the same time before Mike gave any money and anybody made any commitments.
- AC: Okay.
- LL: And I said, look, before we go on, are, are you sure you wanna do this? Yeah, yeah, do it, let's do it, let's do it. I'll never forget So I told mom let's just wait off on this, we'll just hold the property, it's not going anywhere. And I went and did the sports agency.
- AC: Okay. So when things are going bad and you're talking to Reggie and he says he's gonna, he indicated to you he'd give you 40 or 50 grand?
- LL: No, he told me he was going give me back 30 or something, it was a slap in the face where I hung up on him.
- AC: Okay. So that --
- LL: 'Cause whatever it was, it was like 40 or 50 grand less than I'd gaven him directly.
- AC: Okay. And so you hang up on him once he makes that offer and then what happens?
- LLE You know, then he'd call me back, look, you can take this money or leave it. And, you know, text message.
- AC: He text messaged you?
- LL: That's what Brian was talking about the e-mails.
- AC: Do you have copies --
- LL: Text mes -
- AC. -- of those?
- LL: Yes.
- AC: Okay. So he text messaged you take it or leave it?

LL: Basically, here's your 30 --

AC: Did you talk to Lamar?

LL: - well what did it say B?

BW: Here's your money, you can take it or leave it. Some --

PW: Yeah.

BW: -- something to that affect.

PW: Look you can take this money that I got for you or not. It's up to you or something like that.

LL: Yeah.

AC: Did you have any conversations with Lamar or Denise about the conversations you were having with Reggie?

LL: No, I dido't. They were out the picture then. They didn't have any money. They weren't gonna, you know.

AC: They, okay, so when did they become out of the picture?

I.I.: When everything start falling apart. I mean, I was figuring, uh, like December, December, last time I taped 'em, like, right after, December, I never talked to 'em again after that.

RI: So when they're evicted from the property --

LL: I'm in prison when that happened.

RJ: -- but the deals already shot?

LL: Oh, yeah. The deal's shot then.

AC: So the --

PW: 'Cause before you know, after it came out in the newspaper, a couple weeks after that Reggie chose Mike Ornstein and that was in the paper, like a few, a week or so after this. So that's when it was --

AC: A week or two after --

PW: -- a week.

AC: -- you taped?

BW: No, a week or two after, first they announced the, nh, they announced that Reggie had a meeting with seven agents and New Era wasn't mentioned.

LL: And there was, there was the three.

BW: There, there was about a conversation --

LL: No, then it was another meeting with where there was another meeting where there was only three agents where they said --

BW: He narrowed it down to three.

I.I.: -- narrowed it down to three.

BW: And then like a, two, cuuple days after that, he says he chose Mike Orustein. This is all in the newspaper.

AC: Okay.

BW: You can probably --

AC: So you, so you raised some questions to Lamar about the meeting that was reported with the seven agents. And he said oh, it wasn't official, I wasn't even there.

LL: That was Reggie that said that.

AC: Okay, Reggie said it wasn't official.

LL: It wasn't official, I shouldn't have done it, it was bullshit, this is his exact words. And then, uh, Lamar lied and said he wasn't even at the meeting but they said Lamar Griffin was present.

AC: Okay.

LL: So, you know, there's just a bunch of lying going on.

AC: And then another article comes out that says it's narrowed down tn --

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

LL: They narrowed it down --

AC: -- three?

LL: -- to three.

AC: And did you have any conversations with either one of them about once that article came

out?

LL: Nah, it was pretty much a wrap then. It was like --

AC: Did Michaels --

LL: -- 'cause I don't even think we were even conversating then.

AC: - did Michaels have any conversations with them?

LL: He might have. I'm not sure.

AC: Did Cervantes ever have any conversations with Lamar, Denise or Reggie?

LL: Yeah.

AC: With who?

LL: Reggie.

AC: Cervantes had conversations with Reggie?

LL: Yeals.

AC: How do you know that?

LL: Uh, it's on, it's on tape.

AC: There's a taped conversation between Reggie and Cervantes?

LL: Yup.

AC: And did you tape that conversation?

LL: Yeah, but Dave Cervantes knew it was being taped.

AC: And --

RJ: What was the nature of that conversation?

L1.: That was still about money, just to get the proof that it happened, you know, and still trying to recruit him at the time but just had proof that --

AC: So this was the December timeframe?

LL: Yeah, this is December.

RJ: So you're talking to him --

LL: This is like when the articles --

AC: Uh-huh.

LL: -- when it's really out, you know, well I've gota get --

AC: Uh-huh.

LL: -- some proof because right now if I didn't have those tapes where would I say, it was just oo ESPN saying I never gave him any money.

AC: Uh-hub.

LL: If I didn't have those tapes I wouldn't have any proof.

RJ: So when you, when Cervantes is talking to him, but you're, there's still hope that he might still get to stay in the fold and still stay --

LL: Yeah, because he's telling me that on the tape. That, that was bullshit. You guys will get your chance, but then he lied about that. Still, you know

RJ: Okay.

BW: Well explain it a little bit better.

LL: Okay, R's like --

BW: You're saying that --

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

- LL: -- this is --
- BW: -- what you're trying to, because you had so many --
- LL: Let me verbalize it better than 'cause I'm sortof tired. I'm sorry, this is, I just went over this so many times now it gets old but I never went over it with you guys so I gotta be a little bit more descriptive. Okay. After that happened, the, the meetings with the agents and everything, Cervantes was like, hey, what's going on bro? You know, we met with the dad, I left my company, now I'm hearing, you know. So I get Reggie and, on the phone. I'm like, okay, he's trying to like, you kmw, we're, we're getting shammed right now. It's not, you know, he lied to you. So Reggie tells me this line like he tells Cervantes, the same thing he's been saying. Oh, you guys will get your shot as soon the season's over. You'll be one of the first ones orwhatever. So, you know.
- AC: So at that time was there a concern because there, originally you guys had thought he was gonna be with you regardless and now he's saying you'll get your shot?
- LL: Yeah, yeah, right, Yeah, I mean.
- RJ: Let, let me ask you though. I mean, you, you've invested thousands upon thousands of dollars in this guy.
- LL: Yeah.
- RJ: And the family and all of a sudden he's telling you he's just gonna give you a shot?
- LL: Yeal, that's what I'm saying, that's what he told us. Yeah.
- IU: So what did you guys say when he, when he --
- LL: At that time, at that time I didn't wanna get aggressive and argue with him. I just played along with him, like, you know, I'd tell him I, you know, I tell him on the tape. You know, I wouldn't have been in this shit if it wasn't for you, you know. And he thinks in his mind that we probably had a big argument with his dad on the tape, like, well he has the right to change his mind. He's a young kid. So you just can't take everything from people then change your mind, though. Su, I never really, well I was still trying to save hope to sign him but, man, at the end though, I didn't record those conversations with the arguing because it wouldn't record around when he was, ub, basically saying, you know, I had a right to change my mind. You know, I give you all your money back, but he --
- RJ: What's the bottom line as far as why he dumps you guys --
- LL: Ornstein was the whole time. That's, I mean it's obvious.

- AC: So, so you --
- LL: Ornstein had him the whole time.
- AC: -- Lamar and things deteriorate after the ar, the third ar, the second article comes out with Lamar and Denise --
- LL: Yeah.
- AC: -- and you stopped communicating in December with them?
- LL: Yes.
- AC: But they're still living in the house?
- LL: Yes
- AC: And you guys are, are you still paying the rent for them?
- LL: Yes, I'm not, I think I left it alone then.
- AC: But Michaels --
- LL: But Michael was.
- AC. -- was still?
- LL: Yeah, it's in his name, he has to.
- AC: And was there any discussion because I know you said January 18th you went back to prison?
- LL: Yes.
- AC: Prior to that, were there any discussions about them still living in the house and you not even communicating with them anymore?
- LL: No. No. And Michael --
- AC: So --
- LL: -- was still communicating with 'em.

AC: Michael was still --

LL: A little bit.

AC: -- communicating?

LL: Trying to.

AC: Regarding the business or --

LL: Regarding the business.

AC: Okay.

LL: Yeah.

AC: Okay.

LL: Michael still had hope, like naïve hope.

RJ: How, how do you guys find our for a fact that you're out of it and Ornstein's in it?

LL: It says in the paper when he signed.

RJ: He never tells you, you, you --

LL: Yeah, I've gotta read everything in the paper. I mean, I never met anybody that thinks that if I give you \$100 dollars and tell you were starting something, I mean, you've got anticipation on what you're gonna make off your 100, but if something goes wrong I've never heard anybody say, okay, I'm gonna give you \$50 dollars back that you gave me when I gave you 100. I mean, so it was always gonna be a argument from the beginning. Not only is not trying to compensate me for my time that he made me waste in my opinion because I asked him before I started. He tried to give me back less money than I actually gave him but I know what it is. He got so caught up in taking stuff from people, he forgot what he was taking. And that's what I honestly believe happened. He was taking money from a lot of other people.

RJ: Besides Ornstein, who else?

LL: Yeah, I, I've been hearing like what's the one agent name with Will Smith? I know be was at Will Smith's house, went up there for the recruiting thing 'cause he told me about that.

- AC: Reggie told you he went to Will Smith's house?
- LL: He did, yeah. Jamie Fox house. But the Will Smith guy, DeWayne, what's his name?
- BW: I know who you're talking about. Uh.
- LL: Yeah, cau't think.
- AC: He's married to Nakisha Campbell?
- I.I.: Yeah, right. He, he had took him to Will Smith's house and was giving money supposedly. But everybody, like, when it came out, everybody was saying that they had gave him money. So that's what I got. He was taking so much money.
- AC: Reggie told you though that he went to Will Smith's house --
- LL: Yeah.
- AC: -- and --
- LL: Yeah, him and his dad.
- AC: Lamar went to Will Smith's house?
- LL: No, Lamar didn't go but Lamar told me and Reggie told me.
- AC: That they went to Will --
- I.I.: To Will Smith's house.
- AC: -- with this DeWayne guy?
- LL: With just this DeWayne guy.
- AC: and DeWayne was recruiting him?
- LL Trying to recruit him, yeah,
- AC: Okay.
- LL: And trying to use Will Smith as a way to recruit him.

AC: Okay.

RJ: Let's go back. You mentioned, uh, that he had, when, uh, it appeared that there was some e-mails that came to, uh, the USC athletics departm ent saying that Bush has got a car from an agent and his, his parents were living in a house.

LL: It was anonymous.

RJ: Anonymous.

LL: Anonymous tip.

RJ: Okay.

AC. Do you have any information to know who you think might have sent that e-mail?

LL: None. I couldn't figure it out. I was like who would even know because there wasn't too much time; they had not been fiving in the house too, too, too much time when that e-mail came through.

BW: Those reporters found out about the house.

LL: Those reporters found out way late though. This was early, this was like when they --

AC: What reporters --

LL: first moved into --

AC: -- do you know the names?

LL: -- the house.

RJ: When they moved in, you mentioned --

BW: Those, uh --

RJ: -- they, they muved in --

BW: -- those reporters that broke the story.

LL: Yeah, they found out about the house though like 10 months after that.

- RJ: -- then they moved in in March and you're looking at, uh, around May, so they were only in there a couple months.
- LL: Well that was almost a year they were in that house.
- RJ: Before the e-mail came?
- LL: No, they were in the house, when the e-mail came it had to be like May, June. I mean, they weren't in there three/four months.
- RJ: That's what I'm saying.
- LL: Oh, yeah, yeah.
- RJ: They moved in in March -
- LL: Yeah.
- RJ. -- and he walked in and sometime in May.
- AC: You're meaning the story broke 10 months after (unintelligible) --
- LL: Yeah, the tip, the story broke probably 10 months.
- RJ: Your getting back to Reggie calls you and he says to you about, uh, how we're gonna cover car the up.
- LL: Yeah, first he says Darryl.
- RJ: He says his dad.
- L.L.: No, he said Darryl first and he hung up and called me back like 10 minutes later and said, no, no, say my dad bought.
- RJ: Now we're talking his natural father?
- LL: His natural father. He supposedly got a judgment, compensation from workman's compfor 26 grand.
- RJ: Was he ever, was the natural father ever involved in any of this?
- LL: No.

RI: So the only thing he was gonna be used for was an excuse?

LL: Yeah, excuse for the car, where the money came from.

RJ: Okay. But other than that, he's completely out of the picture?

LL: Yes.

RJ: Okay.

AC: Okay. So the text message comes in, take your money or leave it --

LL: Yeah, basically.

AC: -- in December. You reply to that?

LL: I tell him you can have your money, you know, we'll see you in court or something to that affect. I basically said, we're not gonna, I'm not gonna take the money. We'll let a judge or somebody figure out who's right then.

AC: And then what happens after that?

LL: Cornwall called me threatening me.

AC: When, before you went to prison --

LL. Yeah.

AC: -- in January?

LL: Threatened me with prison. I got a e-mail that he sent my sister with those same threats basic --

AC: So Corpwall prior to you going to prison, January 18th, of 2000 --

L. Threatened me with prison, talking about he could make my life hard, he'll call the FBI, he got high-ranking friends in the FBI, he'll get me put in jail, we need to sit down and make this go away. Don't let it get out. You, youknow, we can work, you know, basically that talk.

AC: Okay. And this --

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

BW: This is prior to me getting involved but him prompting that and requesting a meeting, they then called me and said hey, this lawyer guy's threatening me, he wants to have a meeting this weekend and they hired me at that point, a few days before this meeting that Cornwall had set up directly with my clients.

AC: Okay. So he set that up prior to, so this was in January of '06?

BW: This was in January.

LL: Yeah.

PW: Right.

AC: Com --

PW: We will, we will gladly give the e-mails.

AC: Okay, Thank you. So he e-mails you --

LL: He e-mailed my sister at her job, channel 10, trying to threaten her. See he told me, I can make this extortion if you don't leave it alone. And the e-mail, or maybe not the e-mail but on the phone he told me that.

AC: So you had conversations with Cornwall on --

LL: Yeah.

AC. -- on the phone?

LL: Yeah, he told me, you know, you'd better leave it alone. I'll put you in jail and I, and he put it in the e-mail and I said, I said, look, I'm not roaming this and I don't care. Do what you gotta do, put me in jail. I don't care. And be put that in the e-mail he sent my sister.

BW: 'Cause he's threatening to contact his probation officer 'cause he found out that he was on probation. So he says, have you told your probation officer this? I'll talk to your probation officer. I know people in the FBI, so you'd better sit down there and let's resolve this --

LL: And even extortion, though,

BW: -- and let's resolve this. You'd better show up at this meeting set for this weekend. Then they contacted metand today this lawyer, Michaels also, uh, contacted me and said, hey, this lawyer called us up and he's threatening us and saying this, and we've gotta set a

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

meeting and can you go meet with them? He says we gotta go meet with them. So they hired me and then I went there.

- AC: Did you go to that meeting?
- PW: Yes.
- AC: So that meeting occurred with Comwall?
- LL: I was incarcerated then.
- RI: The purpose, the purpose of the meeting was to quote, unquote smooth things over?
- LI.: Yeah.
- BW: To resolve the matter.
- LL: Resolve it.
- RJ: What, what comes out of the meeting?
- AC: So you were not present at the meeting?
- BW: No, it was just me and Mr. Cornwall.
- RJ: So Lloyd, you're, you're gone?
- LL: I'm gone.
- AC: So it was just the two of you? Okay.
- RJ: So just you and, it's just you and Cornwall?
- BW: Cornwall, yes,
- AC: Is that what the meeting after --
- LL: Wasn't Michael --
- AC. -- according to Michaels was a part, or that Reggie and Lamar were --
- BW: No, that was the settlement --

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

AC: -- part of?

BW: -- meeting that they called at, in Joe Siegel's office.

AC: In Santa Monica?

BW: Months, yeah, months later. That's after we'dbeen fighting, litigating.

AC: So a meeting occurred just between your counsel --

BW; And --

AC: -- and Cornwall --

BW: -- Reggie Bush's counsel.

AC: -- in January?

BW: Right.

AC: Okay. And nothing obviously, well nothing came out of that meeting?

BW: We talked and argued for a couple hours and the meeting was fell that he says, you know, uh, make, make --

PW: Since, since you're telling them, you might as well tell them everything

BW: Well actually, no. Then I shouldn't talk 'cause this is attorney, attorney talk. Well, just keep going on with your questions. I didn't even mean to butt in.

AC: So this, so you get this call to meet. You hire, your actorney goes to the meeting, you're incarcerated at this time?

LL: Yes.

AC: So you --

PW: That happened to him within a matter of days.

LL: Yeah,

BW: 'Cause I met with you and then --

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

I think he had something to do with it because that incident happened with the domestic dispute with me and my girlfriend like, ex-girlfriend like December 18th or something. It was like a month went by and it was never no anything. And after that conversation with Cornwall telling me, threatening me with the FBI if I don't leave it alone, I get arrested.

AC: And so did your girlfriend charge you with?

LL: No, she never --

BW: No, it's just a probation violation.

LL: It was a probation violation.

AC: That you had a fight?

LL: Yeah.

BW: When you're on probation, you must act in a --

LL: I never got, yeah, I never got charges filed on that.

AC: So did she ever report it, the incident?

I.L.: Her mom, that's the thing, her mom called the police.

AC In January?

LL: Yeah, no in December.

AC: Oh.

LL: But they never did anything on it. And she's even said that, you know, she wasn't sure exactly 'cause we were drinking, you know, and, but I don't know if it was Cornwall or not but it seemed kind of fishy to me after he threatened me with the FBI and getting me put in jail. A month happened and oothing happened and then after that conversation in a matter of days, they arrest me.

AC: You were going to jail?

LL: Yeah.

RJ: Let me, let mc, ub, think. Tell us about Todd Gandy?

CONFIDENTIAL PURSUANT TO PROTECTIVE ORDER

LL: I don't know nothing about Todd, that's was Michaels' guy.

RJ: Is, uh, Brian do you know anything about him?

BW: No, and we're not the subject of the interview.

RJ: Okay.

BW: Snrry.

RJ: But, uh, is there, is there any reason for us to believe that Mr. Gandy could be involved in NCAA violations?

BW: No.

LL: Oh, no, I don't think so.

RJ: Okay.

AC: Now you mentioned Shug Knight a couple of times.

LL: Yeah.

AC: What was his involvement?

LL: He, he would just try to like mediate it at the end.

AC: And when, when did he get brought in?

LL: At the end. We get, it was just a couple conversation where he heard that Reggie admitted that he did this and they, you know, him and Fasiun both told him, Fasion loved

AC: Now how did --

UL: -- another friend.

AC: -- Fasion play into this, too?

LL: Fasion is my friend, too, and a mutual friend, T-Mac's friend and Reggie's friend, so, you know, it was basically they told Reggie they heard both sides and everybody told Reggie you're wrong. You need to give him the money and make it fair and go on, you guys separate way, but.

And we also were given the opportunity to, uh, to listen to the tape-recordings that Mr. Lake made with Reggie Bush and, uh, Lamar Griffin. And, uh, down the line there's a possibility that those recordings could become available. And we're gonna let Paul Wong make his explanation for the record.

PW: In short, we will provide you with the written documentation, uh, as requested and whatever we have we will provide to you. Uh, that includes the, the items that were discussed previously along with the photographs. With respect to the audio recordings, uh, we, those were procured and secured to prevent fraud. And given the nature of the information contained in there and its value, not just for the impeachment prospective but also to protect our client, we are, we remain concerned that the playing of it and recorded, if it is provided to other parties, either, uh, Reggie Bush's attorneys or some other persons affiliated with him, uh, and the others involved in the recurding that they would somehow

utilize that information to their advantage. But also because it is not clear what the context of this investigation is and how that, those, supplying those recordings to the N-C-double-A would affect our client. AC: For the record you did state that we, we had a chance, we did not listen to the tapes during that break.

PW: Right, But if you like we will play it.

RI: And we would do that off record at the conclusion of the interview.

LL: Excuse me, Michael Michaels, yes.

AC: After he supposedly, allegedly reached his settlement?

LL: Yes.

RJ: It is, it is still in affect? Is there any questions as to whether or not that's been violated?

LL: Yeah, they're working on that right now.
